President's Message



Keeping a Log

A few days ago 15 meters was open and I had just finished a short OSO with IZ6BXV. After saying 73, I routinely entered the contact into my log. Since I am using a computer-based logging program I was able to see that I had worked Tony a few times before, and could even see the dates, times, and frequencies of those contacts. I have been keeping a log since my first day on the air way back in 1965. IZ6BXV was contact number 8625 in my current logging program, but there are many thousands more QSO's recorded in my previous computer-based and paper logs.

My logs go back to the days when the FCC required hams to maintain a meticulous record of all on-the-air activities. My first ARRL logbook (copyright 1964) contained a list of instructions to insure that I met all those requirements. Those instructions included:

- "FCC requires every US amateur to keep a log of *every* transmission... stations called, CQ's, tests."
- "Logs must be kept whether stations are at a fixed location, portable, or mobile."
- "Date, time of transmission, and call are "must" entries."
- "FCC requires that the frequency band used be logged." (note in megacycles)
- "FCC requires statement of the type of emission."
- Power input in watts had to be recorded. (note not the output,

but a calculation of the transmitter's or amplifier's input power)

- "Show the name of the operator, the kind of time, and station call." (note - a signature was also required)
- "It is also required by the FCC's regulations that you must name or record any person talking over a phone transmitter..."

Imagine having to meet those logging requirements today. Every time you key your transmitter, you would have to make an entry in your log. This would include operating in your car or using a handheld while on foot. In the late 1970's, however, the FCC eliminated most of the requirements for keeping a log. One of the few record keeping requirements still on the books is contained in the FCC Part 97 rules under section 97.103(c). It states, "... When deemed necessary by a District Director to assure compliance with the FCC Rules, the station licensee must maintain a record of station operations containing such items of information as the District Director may require..." This is usually applied only in cases where the FCC is investigating alleged rules violations or interference complaints.

So if keeping a log in not required, why do I still keep a log? Well, first let me admit that I do not log mobile and most portable transmissions as this is just not practical. However, keeping a log where possible offers several advantages. The log allows me to:

- keep a record of all the stations I have contacted
- keep a record of how many

contacts I have had on different bands or modes

- check if I have worked a station previously
- keep the records I need to send QSL's
- keep records for contests (most contests require a log to be submitted)
- keep a record of changes in equipment or antennas, and track the on-the-air results
- keep notes about QSO's names, locations, unique or unusual information
- have a record of my station's operations should there ever be complaints of interference or an FCC inquiry
- and more

Whether to keep a log or not is a choice each of us can make. For me, logging is an integral part of the ham radio experience.

INTRODUCTIONS:

MINUTES FROM THE February 7, 2010, MEETING:

A motion was made, seconded and unanimous vote to accept them as printed in the Feedback Newsletter.

TREASURER REPORT- Rich (AG3L):

The club six-month CD is now at \$ 10,000. The remainder (\$3,625.62) was withdrawn to so that the club would still be able to perform its necessary functions. This also leaves \$ 179.94 in the PayPal account.

March 2010 Trip to ARRL HQ

Quick Facts: Date: Thursday March 11, 2010

We left Warminster at 0755 and arrived at W1AW at 1315 after a 45 minute lunch stop at the Westfarms Mall, in Farmington, CT. We arrived back to Warminster at 2040 some 416 miles and 12 hrs 45 min later. There were 30 amateur radio operators attending the trip, representing: RF Hill ARC, SPARC, Penn Wireless and the Warminster Amateur Radio Club.

Our Tour guides: Norm/W3IZ and Bob/WB1GCM

After waiting for weeks, the morning of March 11 was finally here. Everyone started showing up at 0730, and the bus arrived shortly thereafter. Excitement was in the air. We are about to start on an excellent road-trip. Even before we left, Ben (K3JQH) John's XYL, Kass, was very gracious in baking chocolate chip cookies for everyone on the trip, including Sanford Yodel our motor coach driver. She even packaged them individually. On our trip we had 30 amateur radio operators representing 3 clubs in Eastern Pennsylvania. We travelled via Hagey motor coach which was very comfortable in those airline type seats for a long day on the road.

How many times have we heard "at least once in your life, you should visit W1AW"? Well in March of 2010 thirty of us made that pilgrimage to Newington, CT— and we weren't disappointed in the least. The ARRL employees couldn't have been nicer, or more accommodating. They were expecting us and split us into two groups of 15. Our old friend Norm Fusario / W3IZ took one group, and Bob Allison / WB1GCM took the other.

We left the Ben Wilson Center, in Warminster, at 0755 on our 47 passenger Hagey Motorcoach. After a short rest stop near the New Jersey / New York border, we arrived at the Westfarms Mall in Farmington, CT for a 45-minute lunch at 12:00 Noon. The tour started at ARRL HQ after lunch at 13:15.

The lobby in the ARRL HQ Building is where you sign-in and get started on the tours. But it is also where there are a number of historical displays, amatueur radio books for-sale, and ARRL clothing for-sale. Next we were split into 15-person groups and the tours got underway.

First on the tour, we got into some of the radio memorabilia in the display cases. Ever hear of Amateur Radio's legend of the Wouff-Hong and the Rettysnitch? On our trip to ARRL HQ these two amateur radio's sacred symbols were on display. Deep in the myth and lore of amateur radio is the story of Hiram Percy Maxim / W1AW (aka The Old Man) and his instruments of admonishment for any radio operator who used bad and rude operating habits on air. These came into play after WWI as a means to self-improve operating techniques on the bands, which had become atrocious since the WW1 hiatus.

Next we saw what HAM-AID is all about. The 50 pound Go-Kits, obtained with a grant from FEMA will make it possible for the League to loan necessary equipment where it's needed, literally on a moment's notice. This is a program which came into play during the earthquake in Haiti. The HF Kit contains a 100-W HF transceiver, a microphone and a power supply. Norm/ W3IZ was deeply involved in the Haiti tragedy by getting the Ham-Aid Go Kits ready for shipment to designated response teams on scene. More about ARRL's Ham-Aid program is covered in the April 2010 edition of QST.

Our guided tour continued in the HQ Building including: historic displays, graphics department, membership office, workshop, testing lab, shop area, outgoing QSL Bureau, Volunteer Examiner Office, and W1HQ radio station in the ARRL Building for employee use. Next we went over to the highlight of the tour: the Hiram Percy Maxim Memorial Station - W!AW. This station is in a small one-story building which contains the following areas: 3 enclosed guest operating studios, small lobby with some historical radio equipment, enclosed room containing broadcast transmitters and amplifiers for the W1AW Broadcast Bulletins. Station manager's office, and ancillary equipment area.

Each studio is jam packed with 2-3 operating positions utilizing the latest and greatest equipment donated by the manufacturers. Studio 1 where some of us worked had one of those \$10k HFradios by Yaesu. It had the latest of software logging, spectrum displays – equipment that any of us would love to have. Studio 2 had the satellite radios which Richard Housel / K3BFS spent some time looking for the "birds". Studio 2 also had a software defined HF radio, which again was a pleasure to operate. Studio 3 was similar to Studio 1 with HF and VHF/UHF equipment.

The radio equipment was the absolute best state of the art amateur radio equipment – top notch, and expensive for sure. Just operating W1AW alone was certainly worth the trip. Besides the best equipment, we had an outstanding antenna farm with many types of antennas – beams, dipoles, VHF/UHF verticals, and satellite. What a setup!

Since the W1AW Broadcasts start at 1600 local, we need to cease operation in the studios at 1545 to allow time for W1AW Station manager Joe Carcia / NJ1Q to reconfigure the station for the broadcast at 1600. Joe Carcia prepared W1AW Certificates for everyone who operated before we left.

What a great experience! Just operating W1AW was worth the trip. Shortly after 1615, we left Newington and arrived back in Warminster at 2045. If we ever do it again, I'm heading straight for W1AW – it's a shame it's not within the 50 mile radius of Warminster. Imaging how many countries we could work with ease.


