snowfall in Warrington, reported from W3MJP, Mike, which I reported. It was .25 inches more than Ivyland had reported.

George, N3HBT, was monitoring the WARC frequency when I left the radio room. Three amateur operators volunteered to cover for me. Mike N3MJP, Mike KB3GJP, and Hugh N3SOQ. Thank you for offering your services. The EMA is about 10 blocks from my home. I arrived about 2:30 and we were closed down at 7:45 p.m. I did bring with a sleeping bag and pillow. I brought with water and snacks but really didn't need them. The kitchen was stocked with hoagies and chicken soup which smelled good. They had lots of soda, coffee, and snacks. Maybe next time, someone else would like to try manning the radio room. I brought with my class notes for the  $2^{nd}$  EM COMM class I'm taking and was able to finish Lessons 1-5. Everyone staffing the EMA was very professional and relaxed. It was a great experience.

## SOLAR UPDATE

Solar flash Tad "Tequila Sunrise" Cook,K7RA, Seattle, Washington, reports:

This has been a very active week for solar flares and geomagnetic storms. The average daily sunspot number rose more than 57 points this week to 89, and the average daily solar flux was up nearly 43 points to 132.7, as compared to the previous reporting week. The average daily planetary A index more than doubled--from 17.9 to 36.6.

Huge sunspot 720 provided lots of excitement over the past week. Two large flares (coronal mass ejections or CMEs) erupted from this sunspot on January 15. Over the next few days the geomagnetic numbers bumped up dramatically, with planetary A indices of 63, 72 and 62 for January 17-19. The high-latitude collage A indices for the same three days were 114, 136 and 106.

On Monday, January 17, another big flare blasted in our direction. It peaked around 0950 UTC. As sunspot 720 moves off the center of the visible solar disk, more flares erupted, including a huge X7-class event on Thursday, January 20. The energy could sweep past Earth today, January 21.

This flare was the largest of any during the past year, and it triggered the largest radiation storm in the current 11-year solar cycle.

The current prediction is for a planetary A index of 25, 20 and 20 for January 21-23, but these numbers could be higher depending on how direct the radiation hits Earth. With sunspot 720 moving beyond view, daily solar flux values are expected to dip below 100 around January 23-24.

Sunspot numbers for January 13 through 19 were 77, 65, 100, 99, 107, 109 and 66, with a mean of 89. The 10.7 cm flux was 115.6, 129.8, 144.9, 144.5, 137.5, 124.3 and 132.5, with a mean of 132.7. Estimated planetary A indices were 13, 12, 22, 12, 63, 72 and 62 with a mean of 36.6. Estimated midlatitude A indices were 10, 11, 11, 10, 27, 35 and 31, with a mean of 19.3.

## BIG APPLE BROADCASTER AMPS UP ARRL RADIO SPOT FOR LIMBAUGH NETWORK FILL

ARRL Media and Public Relations Manager Allen Pitts, W1AGP, says it's nice to have friends in high places. One of the friends of Amateur Radio public relations is Howard Price, KA2QPJ, of New York City's WABC-TV (Channel 7).

Pitts says Price--acting president of the Broadcast Employees Amateur Radio Society (BEARS) < http://www. w2abc.org/>, the ham radio organization at ABC TV and Radio in New York City and an ARRL Special Service Club--heard the League's new radio public service announcement (PSA) and had an idea.

"He passed it on to Johnny Donovan, production director at WABC Radio in New York City, who dressed it up in one night and made it available as 'network fill' on The Rush Limbaugh Show," heard on hundreds of radio stations across the US. While most larger stations cover program breaks with paid advertising, many smaller stations don't, "and their listeners will hear this wonderfully enhanced PSA for ham radio," Pitts says.

Voicing the beefed-up PSA was Donovan himself, a WABC legend and also a radio amateur. "Folks all over America will recognize his voice from commercial radio," Pitts said.

CrossLink Inc and Alpha/Power Inc to take over production and support of the Alpha/Power line of linear amplifiers and related products. A January 20 Alpha Radio Products press release says Alpha/Power will return to its roots and dedicate itself solely to providing high-power RF equipment "for the professional and serious amateur markets." CrossLink acquired the linear amplifier manufacturer in late 2000. Alpha Radio cited "declining business prospects for CrossLink" for making the ownership change necessary. Alpha Radio President Molly Hardman, W0MOM, assured all current Alpha amplifiers owners that their warranty and service needs will be met. The company says it will continue to employ "the same excellent technicians and assemblers" and manufacture and service its products in the current Boulder, Colorado, location. Chief Engineer Gordon Hardman, WORUN, said Alpha Radio will focus on better control, interface and support components for its amplifiers while leaving primary tube-related components "unchanged and true to their heritage."

### FCC CITES HOMEOWNERS FOR CAUSING INTERFERENCE TO RADIO AMATEUR

Things aren't all that friendly in one Friendswood, Texas, neighborhood, where a dispute over interference from one couple's battery chargers to a neighboring radio amateur has resulted in an official FCC Citation to the couple. The December 10 Citation is the latest chapter in a long-running dispute that FCC Special Counsel Riley Hollingsworth has described as "an unfortunate neighborhood situation." The Citation sprang from complaints by ARRL member William Cooper, W5ZAF, that his next-door neighbors' battery chargers were interfering with his ham radio activities. The FCC concurred.

"Investigation by the FCC's Houston Office revealed that on December 7, 2004, you were operating battery charging devices at your residence," the Citation said. "These devices were observed to be generating radio frequency pulses on various highfrequency radio bands. These radio frequency pulses were determined to be causing harmful interference to the Amateur Radio Service." Only after FCC agents visited the couple's home did the interference cease. The FCC did not make the couple's names

# public nor did it post the Citation on its Web site.

The ARRL Laboratory has been working with the FCC and Cooper to help broker a resolution to the interference issue.

FCC Part 15 rules regulating "unintentional radiators" require that the operator of such devices must cease operation upon FCC notification that it's causing harmful interference. "Operation may not resume until the condition causing the harmful interference has been corrected," the FCC said.

Since it began about a year ago-when Cooper first suspected the interference he was hearing came from his neighbors' Christmas lights--the squabble has escalated beyond the interference issue. Both parties have hired attorneys, and volumes of correspondence have changed hands. Last September, the couple complained that Cooper's antenna support structure violated homeowners' association covenants.

After notices from the FCC's Consumer and Governmental Affairs Bureau went unanswered, Hollingsworth issued warning notices to the couple last June and September alleging that the battery chargers --apparently used to charge some electric scooters -were causing interference. Cooper provided his neighbors with free toroid core devices that resolved the interference, but the couple subsequently removed them. The

(Continued from page 4) couple told Hollingsworth they'd initially been willing to work with Cooper but took out the filters after he allegedly made disparaging remarks about them to another neighbor and took photos of their house and property.

Hollingsworth responded by emphasizing that it's the couple's responsibility to correct the interference--whether or not they accept Cooper's help. Simply unplugging the chargers when not in use--as they had suggested--was not an acceptable solution, he told them in his final Warning Notice. Cooper claimed the chargers had been operating 24 hours a day.

The FCC Citation, which does not require a response from the couple, warned that subsequent violations could lead to fines, equipment seizure and even possible criminal sanctions.

## Echo satellite reopens for normal FM repeater, digital use

The Echo (AO-51) command team says that because no tsunami reliefrelated emergency message traffic has been seen on the AO-51 Packsat Broadcast Protocol BBS (PBBS), it's configured the satellite to permit normal FM repeater and 9k6 digital operation. "The plan is to run in this mode until the end of January, unless word is received from the disaster area that a different setup would be useful," said the AO-51 command team's Mike Kingery, KE4AZN. Because the switch to solely digital store-and-forward operation pre-empted the satellite's use in FM repeater mode for Kid's Day January 2, AMSAT now plans to reschedule its Kid's Day activity on the satellite for an as-yet-unannounced Saturday in February. The AO-51 FM voice uplink is 145.920 MHz (with 67 Hz CTCSS tone required); downlink is 435.300 MHz. The 9k6 digital PBBS uplink is 145.860 MHz FM; downlink is 435.150 MHz FM.--AMSAT News Service

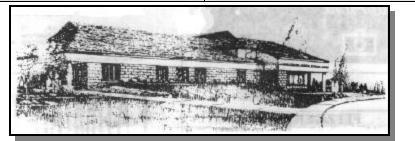
