

#### President's Message

Dispelling myths

As the father of a newborn baby, I've learned a thing or two about how much sleep a person really needs to get by. It really dispels the belief that a good solid 6-8 hors are required. Not only do none of us in the house sleep that may hours at night- none of it is continuous. Yet, my wife still cares for the baby all day and handles innumerable daily tasks, and I get up and go to work. Somehow I get through the day a get the work done with a fraction of the sleep I used to get.

Yes, I am assisted by caffeine-full diet soda, but the point is that there are commonly held beliefs that are just plain wrong.

The House Bill PRB1 in PA is stalled in committee. It was related to me that, at a recent meeting, several historic myths about Ham Radio Operators were thrown out as reasons why PRB-1 should not be allowed to pass.

One is that the towers are unsightly. This is just plain false. If you want unsightly- then look not at the clean silver lines of a HF beam atop a tower that disappear in the afternoon sun. Rather look at dozens and dozens of cellular patch antennas slapped atop a very thick tower that is lined with dozens of heavy black cables- all of which pops up well over the treeline. No matter if you try and "disguise" it with fake tree branches, these towers are part of our lives these days- they are prevalent everywhere and they are far more unsightly than Ham Radio Antennas.

Second, is that Ham Radio Operators



are "cheap." A glance in any Ham Radio Catalog reveals that our handset prices are on par with quality "smartphone" cellular handsets. Nobody calls the BlackBerry a "cheap" piece of gear. Moreover, with high end Ham Radio gear near \$10,000, Ham Radio Operators are more akin to exquisite audiophiles.

Lastly, and most importantly, is the notion that Ham Radio Operators are in the hobby to avoid long distance phone charges. Anyone with a brain would know that a secure, person-toperson call at 4¢ a minute from the home phone is far easier and preferable for deliberate conversation. There's nothing to avoid there.

What all these myths hold at their base is a lack of awareness of what Ham Radio Operators do. Anyone who speaks these myths, or nods when they hear them, has had their head in the sand for decades. They are completely unaware of Ham Radio Operators have been instrumental, and absolutely

essential, after natural emergencies. Existing communications infrastructure becomes damaged, inaccessible and overwhelmed with people trying to communicate.

When the towers fell on September 11, it was Ham Radio Operators who got the word out. This was because the towers held the antennas for cell phones and almost all the broadcast TV in NYC. The loss of the towers meant the loss of cell phone

communication around the towers.

Hurricane Katrina caused the loss of power for weeks in the worst-hit areas. Cell phone towers may have battery backup or generators, but neither work for more than a day or so, and NONE work under water. Ham Radio Operators provided onsite, and mobile humanitarian communication out to where the communications infrastructure did work.

When the great tsunami of 2004 killed more than 225,000 in 11 countries in the east, it was Ham Radio that relayed humanitarian needs out to the rest of the world in minutes.

Ham Radio is communication. That is the core of the hobby. Secondary to that is a very strong emphasis on emergency and public service communication. As a club, we have members involved in more than a dozen public service events throughout the year. Hundreds upon hundreds of man-hours spent helping the community, non-profits and other organizations by providing quality communications services at no cost. All of this is, in essence, practice for an emergency event.

We have many members continuing to study and take exams

to earn emergency service certifications on their own. Hours upon hours learning new skills, participating in drills, developing liaisons with police, fire, and emergency service organizations.

Part of this service is establishing and maintaining a highly capable Ham Radio station at home. Key to this is the ability to erect an antenna and possibly a tower- if the operator so chooses. That individuals and a state government committee could possibly have reason to withhold that capability from Ham Radio operators is unconscionable. 26 other states have already ratified PRB-1 to help assist Ham Radio operators establish capable home stations.

Pennsylvania, as one of the founding colonies of the freedoms we hold so dear, needs to step up to the plate and ratify PRB-1 to enable Ham Radio operators to freely participate in the hobby that may very well save lives in the next emergency. This is senate number SB884 and house number HB1777. No matter flood, ice storm or tornado- all of which Pennsylvania has experienced, it has been and will be Ham Radio operators who are key to providing emergency communications services.

Cell towers are far more

unsightly than Ham Radio towers. Emergencies have shown that the cellular networks are easily overwhelmed and unreliable in big emergencies. Let's help those that are dedicated to emergency public service communications and pass PRB-1 now, without further delay.

#### **SOLAR UPDATE**

Tad "Born of Sun and shower" Cook. K7RA, this week reports: This week several new sunspots appeared for five days, but they were all leftover spots from Solar Cycle 23, not new Cycle 24 spots. But this is okay, because at the sunspot minimum we appreciate any spots we can get. May 16-20 saw daily sunspot numbers of 34, 23, 30, 28 and 23. Sunspot numbers for May 15-21 were 0, 34, 23, 30, 28, 23 and 0 with a mean of 19.7. The 10.7 cm flux was 71.1, 71.6, 71.2, 71.6, 68.9, 68.6 and 69.1 with a mean of 70.3. Estimated planetary A indices were 4, 4, 2, 3, 8, 10 and 13 with a mean of 6.3. Estimated midlatitude A indices were 2, 3, 1, 2, 5, 7 and 9, with a mean of 4.1. Keep in mind that a sunspot number of 34 does not mean there were 34 sunspots last Friday. Instead, the numbers represent a somewhat arcane calculation that accounts for the number of sunspot groups and the size of each group. The count gets 10 points for each sunspot group and one point for each spot within the groups, the designation of these different areas within the groups seeming somewhat arbitrary to a layman such as myself. So 34 could mean that there are three darkened areas, with one of them counting as two spots, the other two just one each. Presumably, the same number would describe the Sun with two darkened areas facing Earth, and each counting for seven spots. Thirty plus four is the same as 20 plus 14, but this week there were three areas. Expect quiet geomagnetic conditions and another prediction for a planetary A index of 25 just before the start of summer on June 17. Geophysical Institute Prague calls for unsettled conditions May 23-24, quiet to unsettled May 25, quiet May 26, quiet to unsettled again on May 27-28 and unsettled for May 29. 


