## **President's Message**

Are You Serious About Public Service?



Emergency Management Now that we are coming up on the 10<sup>th</sup> anniversary of that terrible day of September 11, 2001, it is appropriate to ask: Are you serious about public service? On that day ten years ago this month, we found out that we weren't ready for the aftermath of the attack. A few years later, we suffered through Hurricane Katrina, and

that clearly showed us that we still weren't entirely ready. The preplanning was outdated, and the aftermath was a national disgrace. Disorganization was rampant. Who was in charge?

Organizations were not sure where they fit in, and in some cases competed against other volunteer organizations. There were too few common frequencies, and training of the various groups was not standardized. Something clearly needed to be done. The Federal Government was reorganized, and the new Department of Homeland Security was created. Further down the road, standardized training was mandated at all local, county, state, and federal levels of government and their subordinate agencies.

Here locally, all local elected municipal officials were mandated to take these courses offered by FEMA. As the Chairman of the Township Board of Supervisors at the time, we had to take and pass: FEMA courses IS-100a, IS-200a, IS-700a, and IS-800b. If we didn't take and pass the courses, we would lose all federal funding. That certainly was an incentive to take these courses.

In order to standardize training for large and small emergencies, now all emergency services personnel are required to take and pass the following free courses:

IS-100a An Introduction to the Incident Command System.

IS-200a The Incident Command System for Single Resources.

IS-700a The National Incident Management.

IS-800b National Response Framework Emergencies.

These courses are also mandated as part of the standardized training required by all civilian MARS (Military Auxiliary Radio Service). While not mandated by ARES and RACES, they are recommended. How serious you about your training for public service?

Last year we visited ARRL HQ just after a major hurricane hit the Caribbean island of Haiti. I'll never forget the lecture at ARRL HO by Bob Allison / WB1GCM as he talked about all of the HAM AID equipment flown down to Haiti, and showed us a typical Pelican Case packed with new radios, antennas, generators, manuals, and miscellaneous parts. Bob stated that the days are long gone, when you show up at an emergency without any previous formal training, wave your FCC license, and say I'm ready to go. Bob was absolutely right. Today, whether, you take FEMA courses, RACES or ARES training, or ARRL emergency training – you need some sort of specialized training.

Here in Pennsylvania there are at least 10 potential emergencies that all amateur radio operators should be informed about:

- Floods
- Fires

- Winter Storms
- Tropical Storms, Tornadoes and Wind Storms
- Influenza Pandemic
- Hazardous Material Incidents
- Earthquakes and Landslides
- Nuclear Threat
- Dam Failures
- Terrorism

The first step to disaster preparedness is being informed, and trained. These courses will help you find information about what types of disasters are most likely to occur in Pennsylvania, along with how to prepare for each and what to do if you are actually faced with one of these emergencies.

Don't assume that the area you live in will not be affected by a natural disaster or terrorist attack. No matter where you live, it's important to be prepared

We encourage you to look into the FREE courses offered by FEMA. In addition, to the courses listed herein, there are a few hundred courses offered. Most are FREE. If you want to browse the course offerings, please go to the following website:

Throughout the State, the Pennsylvania Emergency Management Agency (PEMA) coordinates emergency preparedness, response, recovery, and mitigation efforts for natural and manmade disasters such as tornadoes, storms, earthquakes, hazardous materials incidents, including acts of terrorism involving weapons of mass destruction. By working seamlessly with state agencies, local public safety departments and volunteer organizations, Pennsylvania Emergency Management Agency can effectively coordinate response to the emergency needs of the state's 67 counties in times of disaster.

To address the critical need of providing advanced, up-to-date training for Pennsylvania's public safety professionals, the Training and Exercise Management Division was established by law (Title 35) to provide innovative and professional training to state and local emergency management personnel, elected and appointed officials, emergency responders, members of volunteer organizations active in disasters and other professionals who prepare for and respond to emergencies. The division provides public education, professional development training, and technical training to public safety volunteers from state government and local communities across the commonwealth and conducts all hazards related exercises to test preparedness of state agencies, local governments, community public service organizations i.e. schools, hospitals, and others. We also administer a statewide Emergency Exercise Program and oversee the Pennsylvania Emergency Management Coordinator certification program.

Public Education and Outreach includes public safety advisories, press releases, workshops, seminars and statewide conference support aimed at specific audiences.

Pennsylvania law requires that the emergency management coordinator at each level of government earn two levels of certification. A large part of the certification involves completing training offered by PEMA or the Federal Emergency Management Institute. To maintain the proficiency of its staff and to keep its procedures current, PEMA regularly conducts exercises to test the effectiveness of

#### SOLAR UPDATE


Tad "I could feel the Sun on my back <http://www.youtube.com/watch?v=FFthxJKOWok>" Cook, K7RA, reports: Solar activity rose this week, with the average daily sunspot number rising more than 40 points to 66 points, while the average daily solar flux rose more than 13 points to 101.9. The predicted solar flux for August 25-26 is 110, rising to 115 for August 27-30, 110 for August 31, 105 for September 1-3, and 100 for September 4-5. The predicted planetary A index is 5 for August 25-26, 10 on August 27, and 5 on August 28 through September 2, then 8, 10, 10, 10, 7 and 5 on September 3-8.
