K7RA SOLAR UPDATE

Tad Cook, K7RA, Seattle, reports: Solar indices pulled back this week. The average sunspot number was 25.3 for May 19-25, down by 38.8 points from the previous week. The average daily solar flux over the same period was 97, down by 3.4 points from the previous week. Planetary A index average was 7.1, down by 2.8 points, and average daily mid-latitude A index was 7, down by 3.9. This overall decline in solar activity should continue at least for the next 4 years. Compared to past cycles, this one is considerably weaker.

The latest forecast from NOAA/USAF shows solar flux at 95, 90, and 85 on May 26-28; 90 on May 29-30; 85, 95, 90, and 95 on May 31-June 3; 90 on June 4-7; 95 on June 8; 100 on June 9-10; 95 on June 11-12; 90 on June 13-16; 85 on June 17-20; 90 on June 21-25 (except 85 on June 23), and 95 on June 26-30.

The latest prediction for planetary A index is 12, 14, 8, 12, 16, and 8 on May 26-31; 5, 12, 15, 35, 30, and 15 on June 1-6; 5 on June 7-10; 12 on June 11-13; 8 on June 14-15; 5, 15, 12, and 10 on June 16-19; 5 on June 20-21; 12, 10, 8, 5, 15, 12, and 8 on June 22-28; 15 on June 29-30; 35, 30, and 15 on July 1-3, and 5 on July 4-7.

Sunspot numbers for May 19 through 25 were 38, 43, 17, 15, 13, 24, and 27, with a mean of 25.3. The 10.7 centimeter flux was 98.8, 99.5, 97.8, 97.4, 97.4, 94.3, and 93.6, with a mean of 97. Estimated planetary A indices were 8, 6, 15, 7, 5, 6, and 3, with a mean of 7.1. Estimated mid-latitude A indices were 8, 6, 16, 5, 4, 6, and 4 with a mean of 7.

Maritime Mobile Service Network Responds to Mayday Call from Stranded Vessel

The crew of a sailing vessel that foundered on a reef in the South Pacific in early May was rescued in good shape, thanks in part to the alert ear of Maritime Mobile Service Network (MMSN) member Russell Taylor, AI6GV, of San Marcos, California. On May 3, Taylor monitored a "Mayday" call on 14.300 MHz from the Alaska-based *Morning Dove*, at the time some 200 miles northeast of French Polynesia. The vessel's captain, Bruce Moroney, KL3RK, reported that his 46-foot ketch had become stuck on a reef and was unable to move. The crew transmitted the Mayday distress call after the vessel began taking on water.

"I tried to reverse with no effect," Moroney explained afterward to <u>Latitude 38</u>. "Within 10 minutes, conditions became extreme." Moroney said that after the ketch's hull and diesel fuel tank breached, an emergency position-indicating radio beacon (<u>EPIRB</u>) was activated, and a Mayday put out. "Within 15 minutes, the radios were underwater," Moroney said.

Taylor apprised the US Coast Guard of the situation and of the vessel's position. The French Navy subsequently dispatched a helicopter to the area within about 6 hours of the incident, airlifting the four unharmed crew members to safety. Efforts were reported under way to retrieve the grounded vessel.

The Coast Guard later called Taylor, to tell him that had he not monitored the Mayday, the consequences could have been devastating for the crew.

Assisting in the event were longtime net member William Sturridge, KI4MMZ, in Florida, and his friend Peter Mott, ZL1PWM, in New Zealand, who relayed information.

The Maritime Mobile Service Network monitors 14.300 MHz with operators on scheduled shifts from 1700 to 0300 UTC.

"This incident occurred well after scheduled net operations, when propagation on 20 meters usually is minimal at best," Assistant Net Manager Jeff Savasta, KB4JKL, said. He pointed out that MMSN members often continue to monitor the frequency outside of the net's regular schedule, keeping an ear open for just such events. Missouri Radio Amateur Petitions FCC to Designate "Symbol Communication" Subbands

James E. Whedbee, N0ECN, of Gladstone, Missouri, has petitioned the FCC to designate Morse (radiotelegraphy) Amateur Radio band segments as "symbol communication" subbands. The FCC has invited comments on his *Petition for Rule Making* (RM-11769), filed on May 2. Arguing that retaining the current regime of "legacy" CW subbands has proven "grossly inefficient," Whedbee said he'd like to see the FCC delete all privilege restrictions that limit any part of the Amateur Radio spectrum to Morse code to the exclusion of other modes.

"Nostalgia for retention of Morse code telegraphy-only subbands is also an insufficient reason to avoid moving forward to [the] elimination of such subbands, because nothing about this *Petition* suggests the elimination of the mode itself, only that it not be the sole authorized mode in the subject subbands," Whedbee told the FCC.

Whedbee characterized CW-only subbands as "an excessive regulatory constraint, as well as a poor use of the spectrum concerned." He proposed that the FCC's Part 97 rules reflect the "ultimate form of communication reproduced at the receiving end." As he explained it, his regulatory scheme would break down modes into three categories: "Symbol communication mode" -- for CW, digital, and other emission modes that reproduce a discrete symbol on the receiving end; "voice mode," and "image mode."

"[C]ontinuing regulation by specific emission designator is proving to be onerous with changes to the state of the art," Whedbee said. "Accordingly, to continue developing the state of the art in radiocommunications, Amateur Radio needs to clearly get away from regulating in that fashion and return to consideration of what the receiving end of the communication reproduces." Commenters have 30 days to respond to Whedbee's *Petition*. Read more.




